**General Comments**

At the time of the inspection it was observed that all employees had the correct sanitation equipment (Hair nets, gloves, clean clothes, etc.) and employees were preparing individual bags which contained prepackaged food (No cooking needed) items like peanut sandwich, pudding and milk. Furthermore, the milk bags were in coolers which were clean and with correct cold holding temperature.

Temperatures taken:

- Hot water / Handwashing sink: 122°F
- Refrigerators: 35°F to 37°F
- Milk/ Inside Coolers: 36°F to 37°F
- Walk-in refrigerator: 35°F
- Walk-in freezer: 0°F
