(Student MUST park in the space you are assigned. Please don't guess. If you are having a hard time finding your spot, please contact Coach Jay.)

Miami Springs Senior High School and the School Board of Miami-Dade shall not be held responsible for damage to vehicles parked or operated on school property.

1. Students operating a vehicle on school grounds must possess a Florida Class E Driver License.
2. The vehicle must have a valid Florida Registration and be covered by the minimum insurance required by Florida law. Proof of valid insurance and registration must be provided before the application will be accepted.
3. Vehicles operated on school grounds must be in safe operating conditions; school personnel may deem vehicles unsafe.
4. Denial or revocation of a parking permit may result if students exhibit one or more of the following:
 - Excessive absenteeism as defined by more than 4 unexcused absences per marking period or more than 10 unexcused absences.
 - Excessive tardiness as defined by more than 20 tardies to class or school.
 - Accumulated suspensions longer than 10 days per school year.
 - Unpaid fees or obligations.
 - Leaving school without permission.
 - Allowing your vehicle to be used by others to break school rules.
 - Failure to abide by the established traffic patterns, failure to abide by the posted speed limits, and/or careless or unsafe operation of a vehicle.
 - Failure to have a decal properly displayed.
 - Failure to park in assigned parking spot.
5. If a revocation of a parking permit occurs, students may be able to park in the general student parking lot.
6. Students are to park only in the pre-numbered space that corresponds to their individual MSSH permit number on their car.
7. Students are not permitted to remain in their cars or in the parking area after arriving on campus. Loitering in the parking lot will not be tolerated. Students may also not enter the parking area during the school day without first securing permission from school security or administration.
- 8. Any student who changes cars must complete a new application to register the new car.**
9. If your car is disabled for a period of time you must find alternative transportation to school. If you wish to register a second car for your spot you may do so by following the procedures listed above in Rule 8.
10. Any student found smoking/vaping in a car or in the parking lot will have their decal revoked for the school year.
11. Parking permits are not transferable or refundable. Violation of this rule will result in the revocation of senior activities for the remainder of the year as well as revocation of parking privileges.
13. You may appeal suspensions/revocations in writing after fifteen (15) school days. However, some suspensions/revocations are not appealable. Suspensions last a minimum of forty-five (45) days.

* Students must pay for your decal using the District's OSP (Online Student Payment) System. The decal costs \$20.

* Student parking decal should be placed on in a visible location on the front of your car.

* **Students must park in the space given to you.**

* The parking lot gate will be locked at **7:30 am**. If you arrive after that time- you will need to park in the general student parking lot.

*If you are in OJT- you need to sign out with the security desk at the main lobby- so they can inform security to open the lot for your dismissal.

* The parking lot will open at **2:30pm** for dismissal- in order to accommodate for bus pick-up.

* Students will be allowed to paint your parking space. The paint and brushes are the responsibility of the student driver. If your space already has a design- you **MUST** paint in black first before you add your design. All designs **MUST** be school appropriate- in accordance with the Code of Student Conduct.

* Parking Lot Lottery and parking space painting will occur **October 13th from 2:30pm-4:00pm**. In order to participate you must

- Have paid for the decal through OSP
- Signed and returned the Parking contract
- Bring your Driver's License and MSSH School ID for verification
- Bring your own paint and brushes

* Students will only be issued one decal. Thus, if you change cars, please submit the paperwork in for your new car and then transfer your decal to your new car. If your car is going into the shop and you are driving a temporary car, then you will **need to transfer the decal from one car to another AFTER submitting the paperwork for your temporary car.**

* **If you lose your decal, the cost for a new one will be \$20, just as your initial payment. Thus, don't lose it!**
